What are your rights?

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC,

(i) you have the right to request access to your personal data, requesting information about the data processed by the Controller. Information and a copy of the data processed are provided free of charge. For any further copies you request, a reasonable fee based on the administrative costs may be charged.

(ii) you have the right to request the rectification or erasure of your personal data or the restriction of its processing,

(iii) you have the right to request information from the Controller on the recipients who have been informed of the rectification or erasure of the personal data or the restriction of its processing,

(iv) where the legal basis for the data processing is your consent, you have the right to withdraw your consent any time; however, the withdrawal of consent shall not affect the lawfulness of data processing based on the consent prior to the withdrawal. You may withdraw your consent to data processing in person at any CIB Bank Zrt. branch, by calling the CIB24 customer service line at (+36 1) 4 242 242, or through CIB Bank Zrt.'s electronic channels. The CIB Bank Zrt. may still process the personal data even after the withdrawal of consent, for the purpose of compliance with its legal obligations or to pursue its legitimate interests, provided that such pursuit of interests is proportionate to the limitation of the right to the protection of personal data.

(v) where the legal basis of data processing is your consent or the performance of the contract, you may exercise the right to data portability: in respect of your personal data which you have provided to the Controller and is processed by automated means, you have the right to request that you receive this data in a structured, commonly used and machine-readable format and to transmit it to another controller. You also have the right to request – where technically feasible – that the Controller forward your personal data directly to the other controller.

Who are the recipients of your personal data?

The recipients of your personal data are agents and processors of the Controller. The current list of agents and processors and of the functions they perform and more detailed circumstances of the data processing can be accessed on the website www.cib.hu and the notice posted in the branches of CIB Bank Zrt.

In order to ensure compliance with MNB Decree A 35/2017 (XII.14.), in accordance with Sections 4 (5) and (6) of the Decree, the name of the account holder, the international bank account number (IBAN) of the payment account and the assigned secondary account ID are transferred to the organisation operating the central database, and are, in turn, transferred by the organisation operating the central database, in the course of its payment service provision and of the processing, settlement and execution of payment transactions, as well as of requests aimed at the initiating of such, for the purpose of the execution of the payment order, as well as of the forwarding of the payment request, to the financial institutions or payment service providers not classed as financial institutions that are participating in the processing, settlement and execution of the payment transactions.

What legal remedies are available to you?

In respect of the lawfulness of data processing, you may initiate a procedure at the Hungarian National Authority for Data Protection and Freedom of Information (H-1055 Budapest, Falk Miksa u. 9-11, address for correspondence: H-1363 Budapest, Pf. 9., www.naih.hu, phone: +36 (1) 391-1400, fax: +36 (1) 391-1410, central e-mail address: ugyfelszolgalat@naih.hu), or you may seize the court. We recommend that prior to seizing the National Authority of Data Protection and Freedom of Information or the court, you contact our data protection officer.
