## Privacy notice ATM camera footage

Who is the Data controller regarding the processing of your personal data?

The data controller is CIB Bank Zrt. (1024 Budapest, Petrezselyem utca 2-8., Budapest)

Personal Data processed by the Data controller

Personal data on the camera footage (e.g., facial image).

What is the purpose of the data processing?

The purpose of the data processing is to detect and avert situations that directly threaten safety of individuals and property, to investigate any violations of them, and to protect the business, payment, bank, and securities secrets.

What is the legal basis of the data processing?

The legal basis of the data processing is the legitimate interest of CIB Bank [point (f) of paragraph (1), Art. 6. of GDPR]. The processing of personal data is required in order to reach the above purposes and to assert the Data controller's legitimate interest in them, and according to the results of the assessment of interest test performed, your interests, fundamental rights and freedoms, which are to be taken into account during the assessment of interests do not have precedence over those interests.

For what period will your personal data be processed?

The data processing will continue for 60 days from the recording of the footage.

What rights do you have?

Pursuant to the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC

- (i) you may request access to your personal data by requesting information about the data processed. The information and a copy of the processed data are provided free of charge. Additional copies requested may be charged a reasonable fee based on the administrative cost.
- (ii) you may request the rectification, erasure, or restriction of the processing of your personal data,
- (iii) you may request that Data controller disclose which recipients were notified about the rectification, erasure, or restriction of data processing,
- (iv) having regard that the legal basis of the data processing is legitimate interest test, you may object to the processing of your personal data. You can make such objection at CIB Bank Zrt.'s branches free of charge.

Who are the recipients of your personal data, i.e., who can see the footage and your personal data on it?

Recipients of your personal data, other than the data controller, are the applicant authorities, provided that the requested footage is at the Data controller's disposal.

What options are available to you for legal recourse?

Regarding the lawfulness of data processing, you can initiate proceedings with the National Authority for Data Protection and Freedom of Information (1055 Budapest, Falk Miksa utca 9-11., 1363 Budapest, Pf.: 9., website: www.naih.hu, phone: +36 (1) 391-1400, fax: +36 (1) 391-1410, central e-mail address: ugyfelszolgalat@naih.hu) or you can turn to the court. We recommend contacting our data protection officer before you initiate proceedings with the National Authority for Data Protection and Freedom of Information or with the court.
