- ¹ In the case of the account monitoring service, the bank sends an SMS by default for transactions above HUF 500. The customer is free to change this limit via CIB24, or via the bank branch or, in the case of a CIB Private Banking Private Account, via his/her personal banker.
- ² By default, the bank sends an SMS for all transactions when using the card monitoring service. This limit can be freely changed by the customer via CIB24, or via the bank branch, or in the case of a CIB Private Banking Private Account, via his/her personal banker.
- ³ **The monthly fee for the service will be charged monthly in advance, with the first monthly fee being charged on the starting day of use, and then monthly on the same as the starting day of use (the starting day turn day).**
- ⁴ **The fee for SMS messages is charged in arrears on the basis of the SMS messages sent by the Bank. The fee for SMS messages shall be charged in a single amount on the same day of each month as the starting day of the month (starting day) from the day of the application for the service.**
- ⁵ The CIB XL Transfer forint Private Account will be closed by the Bank on 31.12.2021. Simultaneously with the termination, these accounts will be converted into CIB Classic Private Accounts, so from 01.01.2022 the conditions of the CIB Classic Private Account will apply, except for the following rates:
