

## Information on the handover of declaration data when making the Declaration

Please note that after the making of the declaration on the designation of a payment account for free cash withdrawals and cash-back services, the data of the person making the declaration will be forwarded electronically without delay, but certainly no later than within five working days, to BISZ Central Credit Information Ltd., which manages the Central Register of consumer declarations enabling free cash withdrawals and cash-back services.

Please be informed that your declaration data will not be forwarded if you made both your new and previously effective declaration at CIB Bank Ltd.

Please note that the following data are classified as declaration data: personal identity data of natural persons, such as family and given name, family and given name at birth, place of birth, date of birth, mother's family and given name at birth; and in addition to these, the date of making the declaration and the fact that the declaration has been made.

I understand that the personal identity data provided by me (name, family and given name at birth, place and date of birth, and mother's maiden name), as well as the fact of the declaration and the date on which it was made, pursuant to Section 62/B of the Pft., will be forwarded to the Central Register.

I understand that if the date of this declaration is the 20th day of the month or the day preceding that day I shall have the right to free cash withdrawals in respect of the payment account specified in this declaration from the 1st day of the month immediately following the current month, and if the date of this declaration is any day after the 20th of the current month, I shall have the right to the same from the 1st day of the month after the one immediately following the current month.
